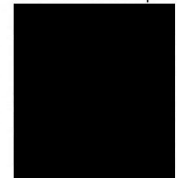

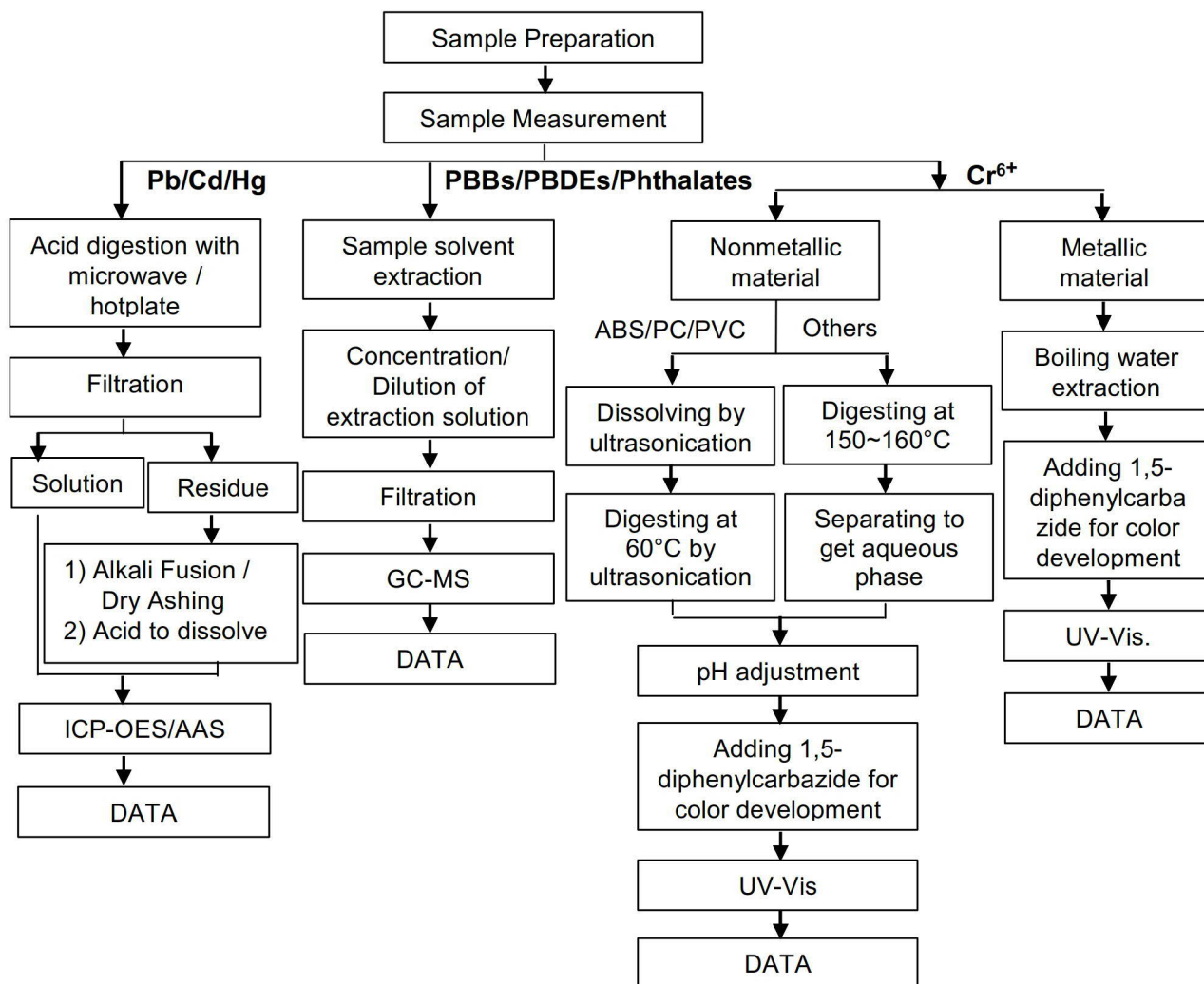

(Cr<sup>6+</sup> and PBBs/PBDEs /Phthalates test method excluded)



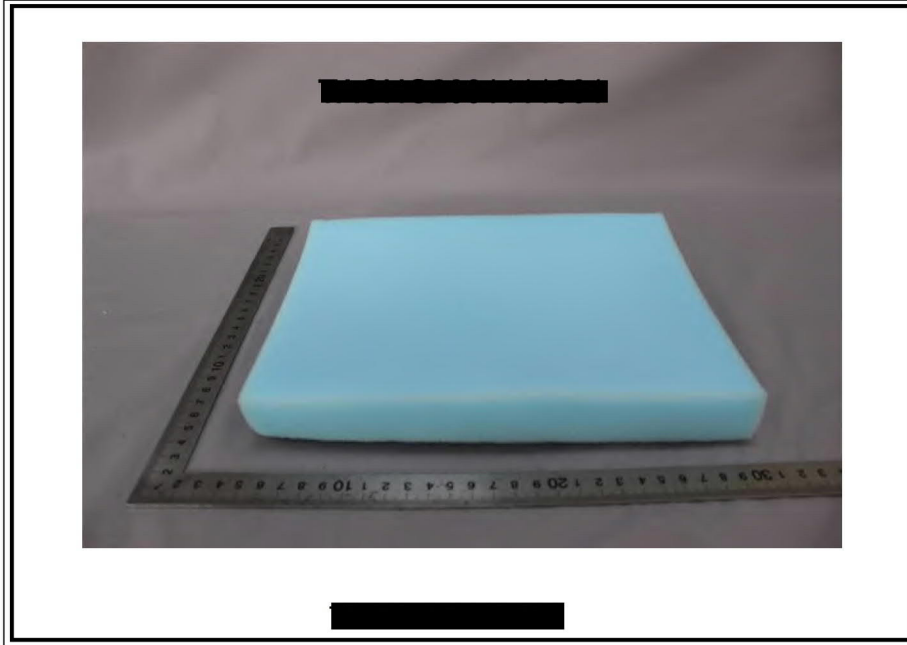
